I have never been convicted of any criminal offense in any jurisdiction in which the elements include the use or attempted use of physical force or threatened use of a deadly weapon against a current or former spouse, a person with whom I have shared a child in common, a person who was or had in the past cohabited with me as a spouse, parent or guardian or who was similarly situated to a spouse, parent or guardian;
13. I am the legal owner of the weapons to be returned (order or other authorization to be attached).
14. No one residing in my home is subject to any of the above disqualifications to possess firearms.
